HEALTH REQUIREMENTS

Exhibition of livestock in Georgia

ALL LAMBS MUST HAVE CURRENT HEALTH CERTIFICATES

- Lambs must be free from any clinical signs consistent with those of foot rot, scabies, contagious ecthyma (soremouth), cutaneous fungal lesions, scrapie or any other contagious disease.
- Lambs must be healthy at receiving and remain so throughout the show. Goats must have health papers, but no official blood test is required.

MARKET LAMB RULES

1. Lamb Classes open only to 4H and FFA members (plus Pre-club) which have pre-entered their lambs with their local County Agent or Vocational Agriculture Teacher prior to August 1, 2009.
2. Entry forms are due by **October 1, 2010**.
3. Entry fee will be \$5.00 per lamb. No fee for Showmanship. Fee is Non-refundable.
4. Lambs will be received **Thursday, October 21st, from 1:00 pm to 4:00 pm**.
5. All lambs may be removed from the barn at the conclusion of the Breeding Ewe Show. No animal should be left over night. Kiwanis will not be responsible for any lamb or ewe left overnight.
6. A Maximum of *three* (3) market lambs per exhibitor will be allowed.
7. Entries must be wethers or ewe lambs and must be polled. NO ram lambs will be allowed.
8. All entries must have tails docked.
9. All lambs must be trained for showing.
10. Lambs **must be tagged** with an official State Tag obtained from the County Extension Agent or Vocational Agriculture Teacher.
11. All lambs must have their milk teeth. The Show Committee reserves the right to mouth lambs to determine age.
12. **Kiwanis Lamb Project** entries will show in a special class. Record Books are part of the project and are to be turned in at check in. Any Project Lamb without a record book will be disqualified for awards in the Kiwanis Class. Project Lambs are expected to show in the regular weight classes.
13. The Fair reserves the right to change, combine or delete classes with insufficient entries. Decisions made by the Livestock Show and Fair Committee regarding rules and regulations are final.
14. Lambs will be shown by weight. Show Committee will determine class break down.
15. Showmanship for Market Lambs and Breeding Ewes will be combined. All entries must be shown by owner unless cleared by the Show Committee. Exhibitors with a handicap or disability may have an assistant as long as the assistant is an exhibitor of this show.
16. **Health Certificates are required. Ewe Lambs must have a scrappie tag.**

HEALTH REQUIREMENTS
Exhibition of livestock in Georgia
ALL LAMBS MUST HAVE CURRENT HEALTH CERTIFICATES

- Lambs must be healthy at receiving and remain so throughout the show.
- No Lambs with soremouth, foot rot or scabies, club lamb fungus, ringworm or any other cutaneous fungal disease will not be allowed in the barn.
- Lambs must have health papers, but no official blood test is required.
- **All Ewe Lambs must have a scrapie tag.**

BREEDING EWE RULES

1. Ewe Classes open only to 4H and FFA members (plus Pre-club) which have pre-entered their lambs with their local County Agent or Vocational Agriculture Teacher prior to August 1, 2010.
2. Entry forms are due by **October 1, 2010**.
3. Entry fee will be \$5.00 per lamb. No fee for Showmanship. Fee is Non-refundable.
4. Lambs will be received **Thursday, October 21st, from 1:00 pm to 4:00 pm**.
5. All lambs may be removed from the barn at the conclusion of the Breeding Ewe Show. No animal should be left over night. Kiwanis will not be responsible for any lamb or ewe left overnight.
6. Not more than *two* (2) ewe lambs can be entered *per class* by an exhibitor and no more than *three* (3) ewe lambs in the *entire show*.
7. Original registration certificates must be in the exhibitor’s name. Farm name will not be acceptable. Original certificate must be presented at check in.
8. All entries must have tails docked.
9. Breed shows will be provided for any breed with five (5) or more entries. Those with less than five entries will be shown in “Other Breeds” Class.
10. Ewes shown in breeding class will not be eligible for the Market Lamb Show.
11. The Fair reserves the right to change, combine or delete classes with insufficient entries. Decisions made by the Livestock Show and Fair Committee regarding rules and regulations are final.
12. All entries must be shown by owner unless cleared by the Show Committee. Exhibitors with a handicap or disability may have an assistant as long as the assistant is an exhibitor of this show.
13. Commercial Ewe Lambs will be shown by weight. Show Committee will determine class break down.
14. **Health Certificates are required. Ewe Lambs must have a scrapie tag.**
15. Registered Ewe Lambs by birth date:

Late Junior Ewes — Feb 16th, 2010 & After
Early Junior Ewe Lambs — Jan 1, 2010 — Feb 15, 2010
Senior Ewe Lambs — Sept 1 — Dec 31, 2009
